Our ability to continue serving our communities depends entirely upon the support, dedication, and active participation of our Companions. Regrettably, we recognize that several of our Companions are no longer actively engaged in the work of Holy Royal Arch Masonry.

The Grand Chapter respectfully calls upon the leadership of every Chapter within this jurisdiction to assist in reclaiming and re-engaging our inactive members. We ask that each Chapter make a sincere effort to contact non-financial Companions and encourage their reinstatement into Holy Royal Arch Masonry. To aid in this effort, **effective immediately through July 31, 2026**, the following dispensation is hereby in place:

STIPULATIONS FOR THIS REINSTATEMENT DISPENSATION

- The individual must be financial in his respective Blue Lodge.
- The individual cannot be under suspension in any Masonic body.
- The individual must have been inactive, or "off the square," in Holy Royal Arch Masonry for a minimum of two (2) years.
- Any items needed by the individual (i.e., ritual, dues card, patent, etc.) shall be obtained at the individual's expense. This reinstatement does not include any such materials.

The Companions in question may reinstate for as little as ZERO dollars. The Grand Chapter will waive all reinstatement fees. The local Chapter, at its discretion, may assess a reinstatement fee not to exceed twenty dollars (\$20.00), if it so desires.

We would consider it both an honor and a privilege to welcome these worthy Companions back into the fellowship and labor of Capitular Masonry, restoring their names to our active membership rolls where they rightfully belong.
